Registration forms will be accepted until the end of the day on Tuesday, June 12th

In order for students to enroll in Summer School through The W.R. Rogers Center, the student **must** have the following at the time of registration:

- Official Withdrawal form from the student's home school
- Completed Counselor Verification Form signed by the student's home school counselor
- Unofficial copy of the student's final transcript
- Valid form of picture ID

Once registered, the student will be scheduled for TABE testing and Orientation. **All students are required to** participate in testing and Orientation prior to beginning classes.

FEES

\$100.00 Enrollment fee- Includes the cost of one course \$50 fee for each additional ½ credit course \$100 for each additional full credit course Course fees are due at registration. Cash, Check, Credit Card and Money Orders are accepted.

All students will have access to the computer lab at The W.R. Rogers Center Tuesday through Thursday 8:30 AM- 12:30 PM.

Students planning to participate in Summer School Graduation must have all course work, including final exams completed by 12:30 PM Thursday, July 19, 2018.
